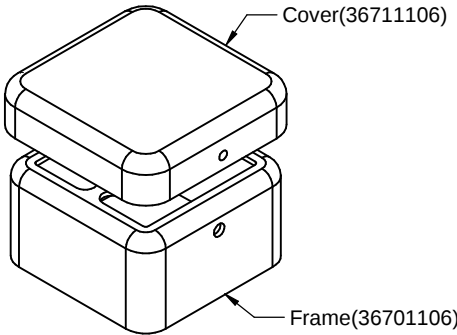


Recommended Land Pattern: [mm]

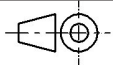
Packaging:
