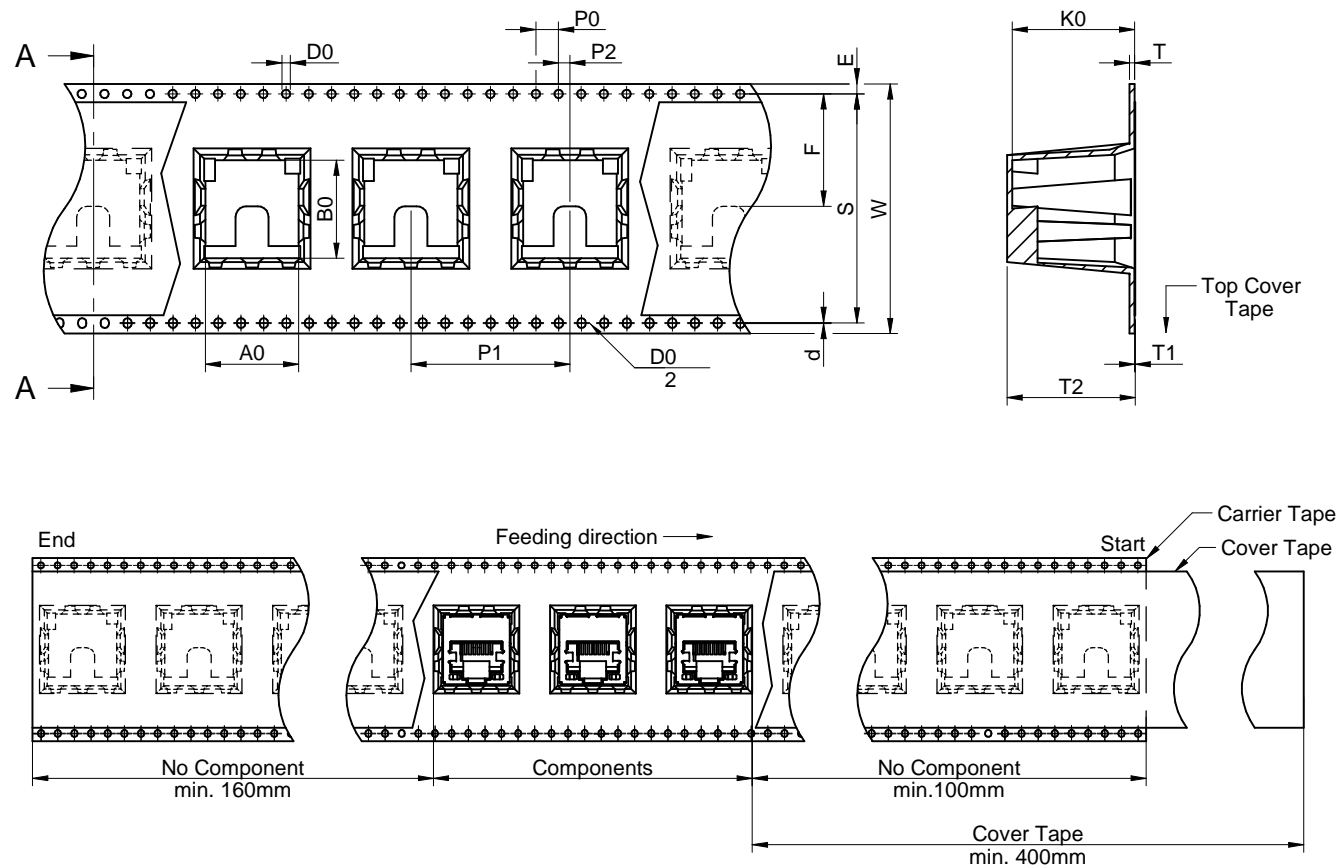
Schematic:



Recommended Stencil Design: [mm]

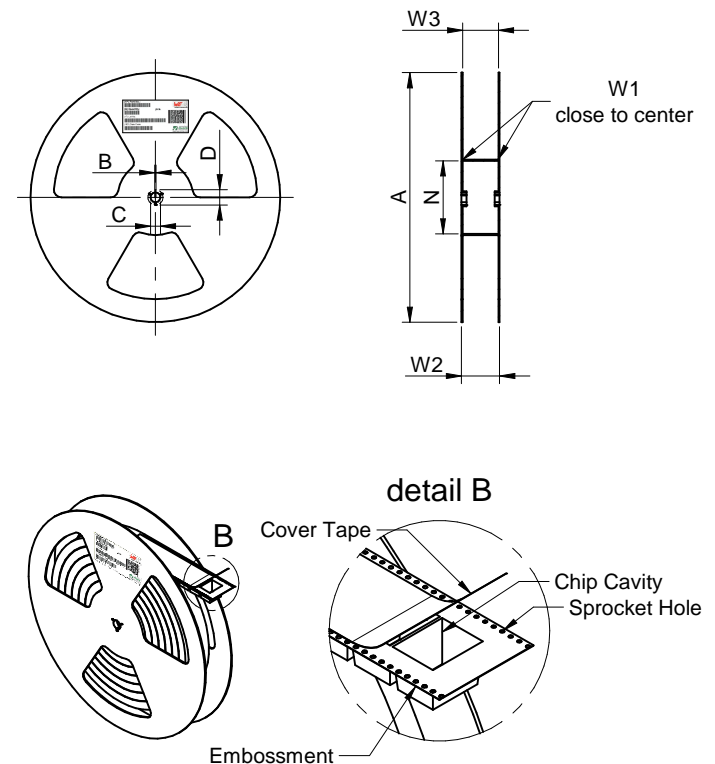
